### **Active - shall make up at least 75% of total membership**

1. The individual must be currently involved in a full-time professional position with primary responsibilities (75% of dollar volume or 75% of time spent) in one or more commercial real estate categories listed in two pull-down menus on the first page of this application form. 2. The individual must have at least five years of full-time experience in a commercial real estate field (or 18 months full-time commercial real estate experience and 5 years or more in another industry at a senior executive level) which is directly and integrally related to the purchase, sale, leasing, management or construction of commercial real estate.

### **Non Active**
